

# Substantial Video Editing Internship Job Description

Substantial is seeking an Intern to support with video editing and captioning. You will be supervised by Substantial's Director of Teaching and Learning, who will provide coaching and guidance to develop your professional skills while completing projects.

Substantial powers <u>SubSchool</u>, an online course and collaboration platform for substitute teachers to build their skills and connect with peers. SubSchool includes nearly 100 short (1 -5 minute) videos, featuring the voices of substitute teachers and education experts, sharing their wisdom, knowledge, and tips. The Video Editing Intern will help to refine and increase the accessibility of our current video catalog, and may support the creation of new videos.

Internship projects may include, but are not limited to:

- Captioning Existing Videos
- Adjusting Volume Levels on Existing Videos
- Smoothing Cuts on Existing Videos
- Suggesting Edits or Changes to Existing Videos
- Supporting New Video Development

- Completed or working toward a college degree (AA or BA), preferably in a related field (e.g., Video Editing, Video Production, Communications etc.)
- Desire to learn more about working in nonprofits & education-sector organizations
- Familiarity with Camtasia editing software, or access to a high-quality alternative
- Strong organizational skills and attention to detail
- Good interpersonal skills
- Commitment to Substantial's mission to unlock the potential of substitute teaching
- Proficiency with Google Suite email, docs, sheets, forms

This is a remote, part-time, temporary internship, and is **paid** at \$18 per hour (up to 80 hours; e.g. 5 hours per week for 16 weeks). This position is not eligible for benefits.
